- 2. Rules:** each race will be conducted by the MSA Race Committee under the following:
  - I. MSA Race Committee Instructions & Sailing Instructions
  - II. Notice of Race.
  - III. MSA Racing Rules.
  - IV. ISAF Racing Rules, as adopted by US Sailing. *These rules have been listed in the order of precedence should there be any conflict between one or more of these rules sources.*
- 3. Membership: Current** PHRF Membership and a valid rating are nice but not required. Current Membership at CYC-Edmonds or at Milltown Sailing Association is required.
- 4. Safety:** All yachts are encouraged to review and comply with PIYA Nearshore+ equipment requirements.
- 5. Fees:** Race fees are waived for the Challenge Cup. A registration must be received prior to the start of the Skippers Meeting. Late entries may be accepted by the Race Committee – however, no bribe and no form and the hard working RC will not be able to score your valiant efforts.
- 6. Verification:** All entrants should be prepared to verify their wiliness to have fun and be respectful of other competitors and sail safely. Club Membership status and PIYA compliance are both highly recommended.
